





It is a mandatory step for validating documents such as educational certificates, marriage or birth certificates, and commercial papers for use in the UAE or abroad



#### LABELLING REQUIREMENTS

01

**Language**: Labels must be in Arabic. While bilingual labels (Arabic and English) are common, Arabic should be the primary language, and its font size should not be smaller than the English text.

#### **DATE CODING STANDARDS**

#### Format:

02

For products with a shelf life of 3 months or less: Day/Month/Year (e.g., 11/06/2025)

For products with a shelf life longer than 3 months: Month/Year (e.g., 06/2025)

**Language**: Dates can be printed in Arabic or English. If both languages are used, the dates must be identical in both languages.

#### **COMPLIANCE AND APPROVAL**



**Regulatory Authorities**: The Dubai Municipality oversees food labelling regulations in Dubai.

**Approval Process**: Before importing products into the UAE, businesses must submit product labels for approval. This ensures that all labelling requirements are met and helps prevent delays at customs.

#### **Our Labeling and Date-Coding Services Include:**



**Fast Turnaround:** We process labeling and date-coding within 48 hours of delivery, ensuring timely readiness for distribution.



**Compliance with UAE Regulations:** All labels are prepared in accordance with UAE food labeling standards, including bilingual Arabic/English labels, and accurate production and expiration dates formatted as day/month/year for products with a shelf life of three months or less, or month/year for longer shelf lives.



**Halal Certification:** For applicable products, we ensure that halal certification is clearly indicated on the label, accompanied by the necessary documentation.



**Batch and Lot Numbering:** Each product is assigned a unique batch or lot number for traceability, enhancing supply chain transparency.



**Storage and Handling Instructions:** Where applicable, we include specific storage and handling instructions to maintain product integrity



**Date Coding**: Production and expiry dates must be printed directly on the original packaging using indelible ink. Stickers are not accepted for date coding.






## **Buyer Consolidation**



Buyer consolidation (also known as cargo consolidation or freight consolidation) is a logistics strategy where a freight forwarder or logistics provider combines multiple smaller shipments from different suppliers—often all destined for the same buyer—into a single, larger shipment.

#### **Purpose**

To reduce shipping costs and improve efficiency.

#### **How it works**

Instead of shipping multiple small loads separately (which is expensive and inefficient), the shipments are **consolidated** at a central warehouse or hub.

#### **End Result**

A single full-container load (FCL) or fewer shipments that are easier and cheaper to manage





#### **Simplified Customs Clearance**

- Consolidated cargo can be cleared as a single shipment.
- Fewer customs entries reduce processing time and the chance of delays or compliance issues

#### **Better Inventory Management**

- Products arrive together, improving coordination for storage, distribution, and sales planning
- Helps maintain just-in-time (JIT) inventory systems.

#### **Lower Carbon Footprint**

- Consolidation leads to fewer transport movements and more efficient use of container space.
- Reduces emissions and supports sustainability goals.

#### **Increased Flexibility**

- Logistics providers can schedule shipments based on readiness, rather than waiting for one supplier to fill an entire container.
- Allows buyers to work with multiple suppliers more easily.

#### **Enhanced Visibility and Control**

- Better tracking of consolidated shipments through one logistics partner.
- Centralized communication streamlines operations.
